RE: Delegation of Authority (DA) – Enter into Written Agreements with Local Law Enforcement Agencies
(Presidential DA 2106)

Chapter 2, Paragraph 203 of the University-wide Police Policies and Administrative Procedures Manual states that The Regents of the University of California are authorized and empowered by California Education Code Section 92600 to appoint peace officers. On December 2, 1998, the President delegated the following authority to Chancellors within their areas of jurisdiction and with appropriate restrictions:

- To enter into written agreements with local law enforcement agencies consistent with Section 67381 of the Education Code.

Effective immediately, as Chancellor and pursuant to the authority delegated to me, I delegate the following authority to you within your area of responsibility:

- To enter into written agreements with local law enforcement agencies consistent with Section 67381 of the Education Code.
 - Each written agreement shall identify either the campus or local law enforcement agency as having operational responsibility for the investigation of Part 1 violent crimes.
 - Each written agreement shall delineate the specific geographical boundaries of each agency's operational responsibility, including maps as necessary.
- Written agreements shall be available for public viewing
- Source of Authority: **Presidential DA 2106**
- This authority may be re-delegated by you.

This delegation supersedes the associated delegation in UC Merced DA 047.

CHANCELLORS**Delegation of Authority--To Enter Into Written Agreements with Local Law Enforcement Agencies Consistent with California Education Code Section 67381**

Chapter 2, Paragraph 203 of the Universitywide Police Policies and Administrative Procedures Manual states that The Regents of the University of California are authorized and empowered by California Education Code Section 92600 to appoint peace officers. The Standing Orders of the Regents 100.4 and 100.6 provide for the delegation of authority for governance of the University to the President and for the governance of a campus to each Chancellor.

Effective immediately, you are delegated authority to enter into written agreements with local law enforcement agencies consistent with Section 67381 of the Education Code. That provision requires that the written agreements identify either the campus or local law enforcement agency as having operational responsibility for the investigation of Part 1 violent crimes, and that they delineate the specific geographical boundaries of each agency's operational responsibility. These agreements shall be in accordance with guidelines to be issued by the Senior Vice President--Business and Finance.

This authority may be redelegated as appropriate.

**Implementation Guidelines
University of California
SB 1729, School Safety, Thompson**

BACKGROUND:

Under existing law, the governing board of each postsecondary educational institution receiving public funds for student financial aid is required to compile records concerning all occurrences of certain criminal and noncriminal activity. UC currently complies in full with this legislation.

The Thompson legislation requires each University of California campus to enter into a written agreement with local law enforcement agencies relating to Part 1 violent crimes, as defined, that designates which law enforcement agency has operational responsibility for the investigation of Part 1 violent crimes and delineates the specific geographical boundaries of each agency's operational responsibility. The bill further requires that these agreements be made available to the public and that copies of these agreements be transmitted to the Legislative Analyst.

The following outlines the University's implementation guideline and approach for each area of the legislation.

PROVISION:

The governing board of the University of California shall adopt rules requiring each of their respective campuses to enter into written agreements with local law enforcement agencies that clarify operational responsibilities for investigations of Part 1 violent crimes occurring on each campus.

IMPLEMENTATION:

The President has delegated to the Chancellors authority to enter into written agreements with local law enforcement agencies.

PROVISION:

Each written agreement entered into pursuant to this section shall designate which law enforcement agency shall have operational responsibility for the investigation of each Part 1 violent crime and delineate the specific geographical boundaries of each agency's operational responsibility, including maps as necessary.

IMPLEMENTATION:

Each campus must enter into agreements which are consistent with this requirement. Agreements must be established by July 1, 1999

PROVISION:

Written agreements entered into shall be available for public viewing by July 1, 1999. Each of the entities shall transmit a copy of each written agreement it has entered into and any other information it deems pertinent to its implementation of this section, to the Legislative Analyst on or before September 1, 1999.

IMPLEMENTATION:

Copies of written agreements shall be provided to the Assistant Vice President--Information Systems and Computing by August 1, 1999. Subsequently, the campus agreements will be transmitted by UC Office of the President to the Legislative Analyst.

Copies of the agreements should also be maintained in the campus Police Departments and available for public viewing no later than July 1, 1999.
